## ORDER GRANTING APPLICATION TO INTERVENE

On November 10, 2022,<sup>1</sup> Evergy Missouri Metro (EMM) filed an application asking the Commission to approve a Special High Load Factor Market rate. On November 14, Google LLC filed an application to intervene. The Commission shortened the time for responses to the intervention application of Google LLC due to a Technical Conference scheduled for November 22. No responses were received.

After considering the unopposed application to intervene, the Commission finds that Google LLC has interests which are different from that of the general public and allowing them to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the applications to intervene.

### THE COMMISSION ORDERS THAT:

1. The application to intervene Google LLC is granted.
2. This order shall be effective when issued.
