On September 14, 2022, the Commission issued its *Order Approving Fuel Adjustment True-Up and Approving Tariff to Change Fuel Adjustment Clause Rates*. The body of the order contains incorrect numbers reflecting the amount the increase will affect a residential customer using 1,000 kWh of electricity per month. The Commission will correct its order as set out below.

### THE COMMISSION ORDERS THAT:

1. The Order Approving Fuel Adjustment True-Up and Approving Tariff to Change Fuel Adjustment Clause Rates issued September 14, 2022, is corrected so that the second full paragraph on page 3 states (the corrected numbers are in bold):

The proposed change to the secondary service FAR, means that a residential customer using 1,000 kWh per month would see an increase in the fuel adjustment charge by about **\$0.17** per month, from **(\$3.66)** to **(\$3.49)** per month.

2. This order shall be effective when issued.
