ORDER GRANTING STAFF’S REQUEST FOR EXTENSION

On April 14, 2023, Union Electric Company d/b/a Ameren Missouri filed its 2022 Renewable Energy Standard (RES) Compliance Report and RES Compliance Plan for calendar years 2023 through 2025. The Commission ordered its Staff (Staff) to review the Report and Plan and to file a report on May 30, 2023. On May 30, 2023, Staff filed a motion requesting an extension of time to file its recommendation to June 29, 2023. In its motion, Staff explained that it required additional information for its report, and time to review Ameren Missouri’s filings. Staff’s motion states that Ameren Missouri does not oppose an extension.

The Commission finds Staff’s request reasonable and will order Staff to file its recommendation no later than June 29, 2023.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding the parties’ joint application no later than June 29, 2023.
2. This Order shall be effective when issued.
