## ORDER DIRECTING NOTICE OF FILING

On April 17, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2022 Renewable Energy Standard (RES) Compliance Report and its 2023 Annual RES Standard Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8). Additionally, Evergy Metro requested a variance from 20 CSR 4240-20.100(8)(A)1.I(V) regarding the provision of meter readings used in the calculation of payments to Renewable Credit Vendors.

Commission Rule 20 CSR 4240-20.100(8)(D) requires the Staff of the Commission to review RES compliance reports and plans and file a report of its review with the Commission within 45 days of the date of filing.<sup>1</sup> The rule also allows the Office of the Public Counsel and other interested persons or entities to file comments within the same 45-day period.<sup>2</sup> Comments on Ameren Missouri's RES Compliance Report and Plan are

due no later than Thursday, June 1, 2023. Any objection to the request for a variance shall also be filed on the same date.

The Commission will direct that notice of this filing be given to potentially interested persons, as required by Commission Rule 20 CSR 4240-20.100(8)(C).

## THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to the county commission of each county within Evergy Metro's service area.

2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing residents of the counties within Evergy Metro's service area, as well as to the news media serving residents of those counties.

3. Staff shall review the RES compliance report and plan and file a report no later than June 1, 2023.

4. Any comments on the RES compliance report and plan shall be filed no later than June 1, 2023.

5. Any objection to the request for a variance shall be filed no later than June 1, 2023.

6. This order shall be effective when issued.
