**STAFF’S RESPONSE TO COMMISSION’S JUNE 23, 2006 ORDER**

COMES NOW the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”) and respectfully states as follows:

1. On June 22, 2006, the Staff filed a pleading requesting, among other things, that the Commission open a docket for purposes of considering the possible adoption of the newly enacted §111(d)(12) Fuel Sources Standard of the Public Utility Regulatory Policies Act of 1978, as required by §1251 of the Energy Policy Act of 2005.
