## EMBARQ MISSOURI, INC. D/B/A CENTURYLINK'S MOTION TO WITHDRAW APPLICATION

COMES NOW, Embarq Missouri, Inc. d/b/a CenturyLink ("CenturyLink") and respectfully moves to withdraw, without prejudice, the application for approval of the interconnection agreement ("ICA") between 365 Wireless, LLC ("365 Wireless") and CenturyLink in order to provide the parties additional time to resolve issues that have been raised in this proceeding. In support of its motion, CenturyLink states:

- 1. On March 12, 2013, CenturyLink filed an application for approval of the ICA that it executed with 365 Wireless. On March 13, 2013, the Commission issued an Order Directing Notice, Setting Intervention Deadline and Making 365 Wireless, LLC a Party.
- 2. On March 13, 2013, Staff filed its Recommendation in this matter setting forth alternatives for the Commission to address issues raised in a similar case involving Southwestern Bell Telephone Company d/b/a AT&T Missouri's ("AT&T Missouri") application for approval of an ICA between AT&T Missouri and 365 Wireless. <sup>1</sup>

- 3. On March 18, 2013, MoKan Dial Inc. and Chariton Valley Telecom
  Corporation filed an application to intervene, stating that the proposed ICA would allow
  365 Wireless to transit its traffic through CenturyLink's network to them for
  termination. They expressed concerns that this traffic would be transited to them
  without compensation or without an approved agreement.
- 4. On March 20, 2013 the Small Telephone Company Group ("STCG") filed an application to intervene, stating similar concerns voiced by MoKan Dial Inc. and Chariton Valley Telecom Corporation.
- 5. As in the case involving 365 Wireless' ICA with AT&T Missouri, 365 Wireless has expressed its desire to CenturyLink to hold discussions with the intervening parties on possible resolutions to the concerns expressed by those parties. These discussions are continuing, with 365 Wireless to provide additional information concerning its network, and the parties endeavoring to convene a face-to-face informational meeting in Jefferson City, Missouri.
- 6. In order to provide additional time for the parties to resolve the issues that have been raised, CenturyLink wishes to withdraw the application to approve the proposed ICA, without prejudice.

WHEREFORE, CenturyLink respectfully requests the Commission grant its motion to withdraw, without prejudice, the application for approval of the ICA between 365 Wireless and CenturyLink.
