## ORDER APPROVING TERMINATION OF ENERGY STAR NEW HOMES PROGRAM, AND APPROVING TARIFF

Issue Date: June 19, 2014 Effective Date: June 21, 2014

On May 22, 2014, Union Electric Company, d/b/a Ameren Missouri, filed a Notification indicating its intent to terminate its Energy Star New Homes Program. At the same time, it issued a revised tariff sheet to implement that change. The revised tariff carries an effective date of June 21. Staff filed a recommendation on June 6, advising the Commission to approve the company's termination of the program and to approve the implementing tariff.

Staff's recommendation explains that the Energy Star New Homes Program was intended to encourage home builders to build energy efficient homes. However, an independent evaluation of the program for Program Year 2013 showed that the program was not cost efficient. Essentially, the program has paid builders to incorporate energy-efficient elements that they would have incorporated even without the incentive program.

That creates what is known as a "free-rider" inefficiency. Staff agrees that the program is inefficient and should be terminated.<sup>1</sup>

Commission rule 4 CSR 240-20.094(5) allows an electric utility to apply to the Commission to discontinue a demand-side program. The rule requires the Commission to approve or reject such an application within 30 days, after providing an opportunity for a hearing. No party has requested a hearing, so no hearing is necessary.

After considering the verified application, along with Staff's recommendation, the Commission finds that Ameren Missouri's application to discontinue its Energy Star New Homes Program should be granted. The Commission will also approve the tariff that implements that discontinuation. Because the tariff will take effect on June 21, the Commission will make this order effective on that date.

## THE COMMISSION ORDERS THAT:

- 1. Ameren Missouri's discontinuation of its Energy Star New Homes Program is approved.
- 2. Ameren Missouri's Tariff No. YE-2014-0473, is approved to become effective on June 21, 2014. The specific tariff sheet approved is:
