Dear Judge Woodruff:

On behalf of The Empire District Gas Company d/b/a Liberty Utilities or Liberty ("EDG"), I am providing herewith to the Missouri Public Service Commission (the "Commission") for filing, in electronic form, certain tariff sheets which are designed to increase EDG's annual base distribution gas revenues by approximately \$1.36 million, exclusive of applicable gross receipts, sales, franchise, or occupational fees or taxes. The proposed increase expressed as a percentage of total revenues, including gas revenues, is 4.16%, or 6.64% excluding gas revenues.

The specific schedules being submitted are shown on the attached **Exhibit No. 1**. All of these schedules bear a date of issue of August 23, 2021, and an effective date thirty days thereafter.

In accordance with Commission Rule 20 CSR 4240-2.065(1), also being provided in electronic form are the verified direct testimonies and schedules of the following EDG witnesses:

The proposed rate increase is necessary to generally offset or reflect increases in operating costs, the construction of new gas service facilities, as well as return requirements on rate base. EDG's base rates were last increased effective April 1, 2010 by virtue of EDG's previous rate case, File No. GR-2009-0434.

The remaining information required by Commission Rule 20 CSR 4240-3.030(3)(B) is being filed herein as part of the Direct Testimony of EDG witness LaToya Johnson, including:

- 1. the amount of dollars of the aggregate annual increase and percentage of increase over current revenues;
- 2. names of counties and communities affected;
- 3. the number of customers to be affected in each general category of service and for all rate classifications within each general category of service;
- 4. the average change requested in dollars and percentage change from current rates for each general category of service and for all rate classifications;
- 5. the proposed annual aggregate change by general categories of service and by rate classifications, including dollar amounts and percentage change in revenues;
- 6. any press releases relative to the filing; and
- 7. a summary of the reasons for the proposed schedule changes.

The tariff filing and supporting testimony supersede a similar filing made on August 16, 2021 which was voluntarily withdrawn by EDG on August 18, 2021 due to an inadvertent error in calculating the revenue requirement.

A copy of this letter and filing is being provided to the Staff Counsel and the Office of the Public Counsel. Please do not hesitate to contact me with any questions or concerns, and please bring these filings to the attention of the Commissioners and the appropriate Commission personnel.
