**STAFF RECOMMENDATION TO APPROVE TARIFF SHEET**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation to approve tariff sheet states:

1. By order issued November 17, 2005 and made effective November 27, 2005, the Public Service Commission of the State of Missouri (Commission) granted Union Electric Company, doing business as AmerenUE, variances from its tariff for the Kingsbury Terrace Apartments, located at 5655 Kingsbury, St. Louis, Missouri, specifically Subpart II. K. of Schedule 5, 6th Revised Sheet No. 144, issued February 14, 2003, effective March 17, 2003, and Subpart V. L. of Schedule 5, 3rd Revised Sheet No. 174, issued July 21, 1995, effective August 26, 1995.

2. In addition, the Commission's order directed, "That Union Electric Company, doing business as AmerenUE, shall file tariff sheets that list all of the variances that the Commission granted in this order no later than December 17, 2005."

3. On December 16, 2005 Union Electric Company filed a tariff sheet bearing an issue date of December 16, 2005 and an effective date of January 16, 2006 that adds to a list of variances granted by this Commission, the number of this case in which the Commission granted Union Electric Company, doing business as AmerenUE, variances from certain provisions of its

tariff for Kingsbury Terrace Apartments, located at 5655 Kingsbury, St. Louis, Missouri, specifically Subpart II. K. of Schedule 5, 6th Revised Sheet No. 144, issued February 14, 2003, effective March 17, 2003, and Subpart V. L. of Schedule 5, 3rd Revised Sheet No. 174, issued July 21, 1995, effective August 26, 1995 and identifies the case number to Kingsbury Terrace Apartments.

4. Although it does not list the specific variances as ordered by the Commission, in the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission issue an Order approving the proposed tariff sheet, as filed on December 16, 2005 to become effective on January 16, 2005, the requested effective date, to wit:
