ORDER ESTABLISHING REQUIREMENTS FOR EVIDENTIARY HEARING

Effective Date: July 5, 2011

On April 27, 2011, the Commission set an evidentiary hearing for August 1, 2011 through August 2, 2011, to determine whether KCP&L Greater Missouri Operations Company ("GMO") violated the terms and conditions of the Nonunanimous Stipulation approved on June 2, 2010. The Commission will direct the parties regarding the preparation for the hearing.

THE COMMISSION ORDERS THAT:

1. All parties tendering expert witnesses at the evidentiary hearing shall file a statement disclosing the identity and biographical background of those experts no later than July 25, 2011.
2. No later than July 25, 2011, the parties shall agree upon, and Staff shall file, a list of the witnesses to appear on each day of the hearing; the order in which they will be called; and the order of party cross-examination for each witness.
3. The parties shall pre-number their hearing exhibits sequentially with individual party designation as exemplified below:
 - a.) GMO Exhibit No. 1, GMO Exhibit No. 2, GMO No. 3, etc.
 - b.) MDNR Exhibit No. 1, MDNR Exhibit No. 2, MDNR Exhibit No. 3, etc.
 - c.) OPC Exhibit No. 1, OPC Exhibit No. 2, OPC Exhibit No. 3, etc.

d.) Staff Exhibit No. 1, Staff Exhibit No. 2, Staff Exhibit No. 3, etc.

4. Each party shall prepare a comprehensive exhibit list before the evidentiary hearing with the listed exhibits numbered sequentially as directed in paragraph 3. Copies of the exhibit lists shall be provided to the Commissioners, the Regulatory Law Judge and the Court Reporter at the beginning of hearing.

5. All parties shall bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. If an exhibit has not been prefiled, the party offering it must bring, in addition to the copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel.

6. This order shall become effective immediately upon issuance.
