**ORDER SUSPENDING TARIFF**

On April 25, 2014, Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri”) filed an application requesting the Commission grant it a variance from certain portions of the Commission’s Electric Utility Renewable Energy Standard Requirements rule in 4 CSR 240-20.100. In order for customers to receive the solar rebate rate of \$2.00 per watt as prescribed by Section 393.1030.3, RSMo Cum. Supp. 2013, the enabling statute for Commission Rule 4 CSR 240-20.1000, the solar electric systems must be operational on or before June 30, 2014. Ameren Missouri is requesting a variance from Commission Rule 4 CSR 240-20.100.4(K), to allow an extension from June 30th to July 31st for inspections of customers’ solar electric systems by certain jurisdictional authorities. Ameren Missouri indicates in its *Application for Variance* that customers have little control over when the authorities having jurisdiction complete required inspections. Ameren Missouri is also requesting variance from the date by which it must provide solar rebate payments to those customers.

On the same day it filed its request for a variance, Ameren Missouri filed tariff sheets revising Schedule No. 6 of its Solar Rebate tariff sheets (Tracking No. JE-2014-0429) with a May 25, 2014 effective date. On April 29, 2014, the Commission issued an order directing the Staff of the Public Service Commission to file a recommendation on Ameren Missouri's *Application for Variance* by May 13, 2014. Staff's recommendation urges the Commission to deny Ameren Missouri's application and reject its proposed tariff sheets. On May 16<sup>th</sup>, the Commission issued an order scheduling a May 29<sup>th</sup> pre-hearing conference in this matter. Since a potential dispute exists, the Commission will suspend the tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. The following proposed tariff sheets filed by Union Electric, d/b/a Ameren Missouri are suspended until August 23, 2014 or until further order of the Commission:
