**ORDER PROVIDING NOTICE, ESTABLISHING TIME FOR RESPONSE, AND
DIRECTING STAFF RECOMMENDATION**

On April 30, 2014, KCP&L Greater Missouri Operations Company ("GMO") asked the Commission to grant it a variance from certain requirements of the Commission's Integrated Resource Planning Rule, 4 CSR 240-22. GMO asks the Commission to grant a variance from the Commission rules requiring regional transmission organization expansion plan analysis specific to Missouri customers.

The Commission will allow time for potentially interested parties to respond to GMO's request, and will order a Staff Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall mail a copy of this order to all parties to KCP&L Greater Missouri Operations Company's previous integrated resource planning case, EO-2012-0324.
2. The Staff of the Commission shall file a recommendation or, in the alternative, a status report stating when it plans to file its recommendation, no later than May 22, 2014.
3. Any other party wishing to respond shall do so no later than May 22, 2014.

4. This order shall become effective immediately upon issuance.

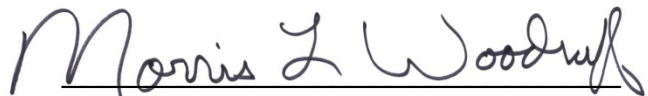
