NOTICE OF CORRECTION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through undersigned counsel, and for its *Notice of Correction* respectfully states:

1. On January 26, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro submitted tariff revisions, Tariff No. JE-2021-0144, bearing an effective date of February 25, 2021, and containing revisions to Evergy Missouri Metro’s tariffs for standardized rates for facilities at or under 100 kilowatts design capacity.

2. Staff filed its *Staff Recommendation to Approve Tariff Sheet* and corresponding Memorandum on February 16, 2021, in which Staff recommended the Commission approve or permit Evergy Missouri Metro’s tariff sheet to go into effect for service on and after February 25, 2021.
