On July 29, 2022, Union Electric Company d/b/a Ameren Missouri filed a motion asking that it be allowed additional time to reply to a response filed by Public Counsel. By terms of Commission Rule 20 CSR 4240-2.080(13) that response would be due on August 1, 2022, ten days after Public Counsel filed its response. Ameren Missouri asks that it be allowed until August 18, 2022 to respond. The Commission will grant that request.

### THE COMMISSION ORDERS THAT:

1. Ameren Missouri's Motion for Extension of Response Deadline is granted.
2. Ameren Missouri shall file its reply to Public Counsel's response no later than August 18, 2022.
3. This order shall be effective when issued.
