**STAFF REPORT ON AMEREN MISSOURI’S
2019 - 2021 RENEWABLE ENERGY STANDARD COMPLIANCE PLAN**

COMES NOW the Staff of the Missouri Public Service Commission and submits its *Staff Report on Ameren Missouri’s 2019 - 2021 Renewable Energy Standard Compliance Plan* as ordered by the Commission. In support thereof, Staff states as follows:

1. On April 15, 2019, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”) filed its Renewable Energy Standard (“RES”) Compliance Plan 2019-2021 (“Plan”) as required by rule.¹

2. Commission rule 4 CSR 240-20.100(8) states “. . . Each electric utility shall file an annual RES compliance plan with the commission. The plan shall be filed no later than April 15 of each year.”

3. Rule 4 CSR 240-20.100(8)(B) specifies what information the utility must provide in its annual RES Compliance Plan.

4. Rule 4 CSR 240-20.100(8)(D) provides that:

The staff of the commission shall examine each electric utility’s annual RES compliance report and RES compliance plan and file a report of its review with the commission within forty-five (45) days of the filing of the annual RES compliance report and RES compliance plan with the commission. The staff’s report shall identify any deficiencies in the electric utility’s compliance with the RES.

¹ That same day Ameren Missouri also filed its 2018 RES Compliance Report in the same file. Staff will address that Report in a separate report.

5. On April 17, 2019, the Commission issued its *Order Directing Notice And Setting Filing Deadline*, directing the Staff to file a report of its review of the Company's 2019-2021 Compliance Plan no later than May 30, 2019.

6. Staff has conducted its review of Ameren Missouri's 2019-2021 RES Compliance Plan as discussed in detail in the attached Memorandum which is incorporated herein by reference and states that the Company has met the minimum requirements for the Plan.

WHEREFORE, Staff submits its report for the Commission's information and consideration regarding Ameren Missouri's 2019-2021 RES Compliance Plan.
