**ORDER EXTENDING TIME FOR AMEREN MISSOURI
TO PROVIDE ADDITIONAL ANALYSIS**

On August 18, 2021, the Commission issued an order that found that Union Electric Company d/b/a Ameren Missouri's 2020 Triennial Integrated Resource Planning (IRP) filing complies with the requirements of the Commission's rules. That order also required Ameren Missouri to "provide detailed analysis comparing ratepayer risks and shareholder risks for additional generation resources which are not required to meet federal, state, or MISO requirements as part of its next IRP annual update." That additional analysis was requested by Staff. The Commission's August 18 order became effective on September 17, 2021.

On September 9, 2021, Ameren Missouri filed a timely motion for reconsideration. Ameren Missouri's motion points out that it intends to file its next annual IRP annual update on October 1, 2021, and indicates it will not be able to provide the required detailed analysis by that time. It asks instead to be allowed until December 15, 2021 to provide that analysis.

The Commission directed its Staff to respond to Ameren Missouri's request, and on September 16, 2021, Staff indicated it does not object to Ameren Missouri's request for additional time to provide the required analysis. No other party has responded to Ameren Missouri's request.

After considering Ameren Missouri's request for additional time to perform the analysis, the Commission will grant that request.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri is allowed until December 15, 2021, to provide detailed analysis comparing ratepayer risks and shareholder risks for additional generation resources which are not required to meet federal, state, or MISO requirements.
2. This order shall be effective when issued.
