On August 18, 2021, the Commission issued an order regarding Union Electric Company d/b/a Ameren Missouri's 2020 triennial integrated resource planning (IRP) compliance filing. Among other things, that order directed Ameren Missouri to "provide detailed analysis comparing ratepayer risks and shareholder risks for additional generation resources, which are not required to meet federal, state, or MISO requirements as part of its next IRP annual update." On September 9, 2021, Ameren Missouri filed a timely motion for reconsideration. That motion explains that Ameren Missouri will be unable to complete the required analysis by the time it files its next IRP annual update on October 1, 2021. Ameren Missouri asks that the Commission modify its order to require the analysis to be filed by December 15, 2021.

The Commission will direct its Staff to respond to Ameren Missouri's Motion for Reconsideration.

- 1. Staff shall file a response to Ameren Missouri's Motion for Reconsideration no later than September 17, 2021.
  - 2. This order shall be effective when issued.
