ORDER EXTENDING DEADLINE

On June 9, 2021,¹ the Commission issued its Report and Order Approving Third Addendum to Territorial Agreement. On June 23, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) issued its compliance tariff, Tracking Number YE-2021-0256, with an effective date of July 23, 2021. On June 23, the Commission issued its Order Directing Staff Recommendation regarding Evergy's compliance tariff be filed no later than July 9. On July 9, Evergy and the Staff of the Commission (Staff) filed a Joint Motion for Extension. The Motion states that Evergy plans to substitute its compliance tariff and requests that the Commission extend the due date for Staff's recommendation to July 19, 2021. The Commission will grant the request but will shorten the deadline slightly, so that the Commission can consider the compliance filing during its July 21, 2021 regularly scheduled agenda meeting, if needed.

THE COMMISSION ORDERS THAT:

1. The Joint Motion for Extension is granted.

2. Staff shall file its recommendation regarding Evergy's compliance tariff revision YE-2021-0256 no later than 10:00 a.m. July 19, 2021.

3. Any other party wishing to respond to Evergy's compliance tariff shall do so no later than 10:00 a.m. July 19, 2021.

4. This Order shall be effective when issued.
