ORDER DIRECTING FILING AND SETTING DEADLINE FOR OBJECTIONS AND COMMENTS

On August 4, 2021,¹ The Commission issued its Report and Order Approving Territorial Agreement. The Report and Order required Evergy Missouri West, Inc., d/b/a Evergy West (Evergy) to file compliance tariff sheets describing the modification of its service territory which include a metes and bounds legal description of the affected parcels no later than October 3. On August 18, Evergy filed a tariff revision pursuant to the Commission's Report and Order with an effective date of September 3. The tracking number is YE-2022-0038. The Commission will order the Commission Staff (Staff) to file a recommendation and set a deadline for objections or comments on the tariff.

THE COMMISSION ORDERS THAT:

1. The Commission Staff shall file a recommendation on compliance tariff tracking number YE-2022-0038 no later than August 23, 2021.
2. Any objection or comment on the tariff shall be filed no later than August 23, 2021.

3. This Order shall be effective when issued.
