NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: September 27, 2021

In File No. EO-2022-0027, Union Electric Company d/b/a Ameren Missouri submitted its true-up filing for its fuel adjustment clause (FAC) as provided by Commission Rule 20 CSR 4240-20.090(9). Ameren Missouri also submitted a revised tariff sheet, Tracking No. YE-2022-0025, to change its fuel adjustment rate (FAR) in File No. ER-2022-0026. The tariff sheet bears an effective date of October 1, 2021. On September 15, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Resolving Annual Fuel Adjustment Clause True-Up, and Directing Filing of Substitute Tariff*.

In response to the Commission's order, Ameren Missouri filed a substitute tariff sheet on September 15, 2021, and filed a corrected substitute tariff sheet on September 20, 2021. The Commission directed the Staff of the Commission to review the tariff sheet and inform the Commission as to whether it complies with the Commission's order. Any other response was directed to be filed no later than September 24, 2021.

On September 23, 2021, Staff filed its recommendation. Staff stated it had reviewed the compliance tariff, as substituted and corrected on September 20, 2021, and found that it complied with the Commission's September 15th order. Staff recommended that the Commission approved the tariff sheet to become effective on October 1, 2021. No other responses to the tariff have been filed.

The Commission has considered the compliance tariff sheet, as substituted and corrected, and Staff's recommendation. The Commission will allow Tracking No. YE-2022-0025, as substituted and corrected, to take effect by operation of law on October 1, 2021.
