## **ORDER SCHEDULING ON-THE-RECORD PRESENTATION**

On December 26, 2006, the Commission set a date for the parties in these matters to file pleadings addressing the threshold question on the applicability of the prior state action exemption to the adoption of the Net Metering Standard, the Time-Based Metering and Communications Standard, and the Interconnection Standard. These pleadings were directed to be filed no later than February 9, 2007.

A decision by the Commission that prior state action has satisfied EPA's current requirements would terminate these proceedings, while an opposite decision would require the Commission to initiate rulemaking for the purposes of adopting the standards. The Commission has reviewed the pleadings filed by all of the parties in these matters, finds

that these standards have issues in common, and has questions for the parties. Accordingly, the Commission will schedule an on-the-record session to allow the parties' representatives and experts to address the Commission's questions.

**IT IS ORDERED THAT:**

1. An on-the-record presentation is scheduled for April 25, 2007, beginning at 8:30 a.m. The presentation will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This presentation will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
