ORDER OF RULEMAKING

By the authority vested in the Missouri Public Service Commission under sections 386.300 and 386.410, RSMo 2000, the commission amends a rule as follows:

4 CSR 240-2.030 is amended.

A notice of proposed rulemaking containing the text of the proposed amendments was published in the *Missouri Register* on April 15, 2011 (36 MoReg 1041). Those sections with changes are reprinted here. These proposed amendments become effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: A public hearing on the proposed amendments was held May 19, 2011, and the public comment period ended May 16, 2011. The commission received one (1) written comment on the rule.

COMMENT: Lewis Mills with the Office of the Public Counsel commented that the types of documents that may be requested should remain in the rule for informational purposes.

RESPONSE AND EXPLANATION OF CHANGE: The commission agrees that a list of some of the documents that can be requested may be helpful to the general public. The commission adds that information back into section (2).
