On June 30, 2023, the City of Kansas City filed an application to intervene in these matters. Kansas City also filed a request for expedited treatment to participate in July 6, 2023 party discussions where confidential information will be presented. Kansas City filed three non-disclosure agreements on July 5, 2023. The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075.

Commission rule 20 CSR 4240-2.075(9) permits the Commission to limit intervention to particular interests in a case. Due to the short time prior to the July 6, 2023, party discussions, the Commission will grant limited intervention so that Kansas City may participate in the July 6, 2023 discussions. However, because ten days have not passed since Kansas City filed its request, the Commission will still consider any objections to Kansas City's full participation as a party in these matters.

THE COMMISSION ORDERS THAT:

1. Kansas City's application to intervene is granted for the limited purpose of participating in the parties' July 6, 2023 discussions.
