On February 16, 2023, John J. Lindsay filed an application with the Missouri Public Service Commission requesting a change of electric supplier from The Empire District Electric Company, d/b/a Liberty to New-Mac Electric Cooperative (New-Mac). On February 16, 2023, the Commission issued a notice to Liberty and New-Mac, joined them as necessary parties, and ordered them to respond to the application no later than March 20, 2023.
