On December 30, 2005, Nexus Communications, Inc., d/b/a TSI, filed its application with the Missouri Public Service Commission for designation as an eligible telecommunications carrier with respect to federal universal service support under Sections 214 and 254 of the Telecommunications Act of 1996 and the implementing regulations of the Federal Communications Commission. TSI is authorized to provide basic local exchange service and interexchange services in Missouri. TSI requests designation as an eligible telecommunications carrier in the exchanges of Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, as listed in Exhibit D of TSI's application.

The Commission finds that proper persons should be allowed an opportunity to file a motion for leave to intervene in this matter. The Commission also finds that notice of this application should be sent to all telecommunications carriers certificated to operate in Missouri. Further, the Commission finds that the Public Information Office of the Commission must provide notice to the members of the General Assembly and to the news media.

IT IS THEREFORE ORDERED:

1. That the Data Center of the Missouri Public Service Commission shall send notice of this application to all telecommunications carriers certificated to operate in the state of Missouri.

2. That the Public Information Office of the Missouri Public Service Commission shall provide notice of the application to the members of the General Assembly and to the news media.
