STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

- 1. Xspedius Management Co. of Kansas City, LLC and Xspedius Management Co. Switched Services, LLC have filed a joint application for approval of a merger between the two companies, with Xspedius Management Co. Kansas City, LLC as the survivor, in Case No. TM-2007-0472. In conjunction with that case, Xspedius Management Co. Kansas City, LLC has filed the present case to obtain a certificate of service authority to provide basic local telecommunications services so that "Xspedius KC, as the surviving entity following the merger, [may] have the certificate of service authority to be able to assume and provide all basic local exchange services currently provided by its affiliated company, Xspedius Switched Services, under the latter's existing basic local exchange certificate of service authority". Staff provides its recommendation at this time.
- 2. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission grant Xspedius Management Co. of

Kansas City, LLC (Applicant), a certificate of service authority to provide basic local exchange telecommunications service in the service area of Southwestern Bell Telephone L.P. d/b/a AT&T Missouri; Embarq Missouri Inc. d/b/a Embarq; CenturyTel of Missouri, LLC; and Spectra Communications Group, LLC d/b/a CenturyTel, conditioned upon certain access rate provisions. The Commission shall grant an application for a certificate of telecommunications service authority upon a finding that the grant of authority is in the public interest. (See §392.430 and §392.440 RSMo. (2000).)

- 3. Staff also recommends that the Commission classify the Applicant and its services as competitive. The Commission may classify a telecommunications provider or its services as competitive if the Commission determines it is subject to sufficient competition to justify a lesser degree of regulation. (See §392.361.2.) All the services a competitive company provides must be classified as competitive. (See §392.361.3.)
- 4. Staff also recommends that the Commission grant approval of the Applicant's proposed tariff sheets to adopt the existing basic local tariffs of Xspedius Management Co. Switched Services, LLC (MO PSC No. 4 and MO PSC No. 7), with proposed effective dates of August 11, 2007.
- 5. Staff has already addressed the background of Xspedius Management Co. Kansas City, LLC's *Application for Waiver* to waive the relevant paragraphs of 4 CSR 240-3.510(1)(D)1 in Staff's *Response to Order Directing Filing* submitted on July 10, 2007. Staff has no objection to the request for waiver and recommends the Commission waive those provisions.

WHEREFORE, Staff recommends that the Commission grant Xspedius Management Co. of Kansas City, LLC a certificate to provide basic local exchange telecommunications services, conditioned upon the access rate provisions described in the Staff memorandum; grant

competitive classification; grant a waiver of the statutes and regulations listed in the Commission's *Notice of Applications*, as well as of 4 CSR 240-3.510(1)(D)1; and approve the Applicant's proposed tariff sheets adopting the existing basic local tariffs of Xspedius Management Co. Switched Services, LLC (MO PSC No. 4 and MO PSC No. 7), with effective dates of August 11, 2007.

The applicant has met Staff's review of requirements for obtaining a certificate of service authority and tariff approval. Therefore, Staff recommends the applicant be granted the following certificate(s), as indicated below. The certificate shall be conditioned to become effective on the same date the tariff becomes effective; however no later than the approval date of the transaction involving the competitively classified companies.
🔀 certificate to provide basic local exchange telecommunications services. Granting the certificate should be based on the following conditions:
 The applicant's originating and terminating access rates will be no greater than the lowest Commission approved corresponding access rates in effect for each ILEC within whose service area the applicant seeks authority to provide service, unless authorized by the Commission pursuant to Sections 392.220 and 392.230 RSMo. The certificate and service classification for switched access service is conditioned on the continued applicability of Section 392.200 RSMo, and the requirement that any increases in switched access services rates above the maximum switched access service rates set forth herein shall be made pursuant to Sections 392.220 and 392.230 RSMo, and not Sections 392.500 and 392.510 RSMo. Xspedius Management Co of Kansas City LLC tariff MO PSC No. 1 is to be cancelled upon merger of Xspedius Management Co of Kansas City LLC and Xspedius Management Co. Switched Services, LLC and renaming surviving company Time Warner Telecom of Kansas City LLC, per request in paragraph 8 of Supplement to Applications filed 7/13/07 in TM-2007-0472 and Case No. CA-2007-0473. No customers are receiving service under this tariff.
