**MOTION FOR EXTENSION OF TIME**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and for its *Motion for Extension of Time* hereby states:

1. On September 28, 2017, Complainant filed her *Complaint* in this docket.
2. On October 13, 2017, Respondent filed a *Request for Mediation and Motion for Stay or Extension of Time to File Answer*.
3. On December 13, 2017, a mediation session was held and the parties were unable to reach mutual resolution.
4. On December 22, 2017, the Commission ordered Staff to coordinate with the other parties and file either a proposed procedural schedule or proposed dates for a procedural conference (the "Order"), no later than January 8, 2017.
5. On January 8, 2018, Staff filed a *Partial Proposed Procedural Schedule*, in which it recommended that Respondents be required to file an *Answer* by January 19, 2018, in order for Staff to file its *Report* by February 2, 2018. As discussed in that filing,

Staff required two weeks after the filing of the *Answer*, consistent with Commission rules, to complete its review and provide a *Report*.

6. On January 9, 2018, the Commission issued its *Order Setting Initial Procedural Schedule*, which required Respondent to file its *Answer* no later than January 23, 2018, and Staff to file its *Report* no later than February 2, 2018. This schedule reduced the time for Staff to complete its investigation.

7. Staff is still working toward completing its investigation and *Report* and respectfully requests additional time to file. Staff anticipates completing its investigation and *Report* no later than February 13, 2018, but will file earlier if possible.

**WHEREFORE**, Staff respectfully submits its *Motion for Extension of Time* for the Commission's consideration and requests the Commission grant Staff an extension to file its *Report* no later than February 13, 2018.
