PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and hereby files its *Proposed Procedural Schedule*, in response to the Commission's March 21, 2018 *Order Denying Motion to Dismiss and Directing Filing* ("March 21 Order"):

1. On September 28, 2017, Complainant filed her *Complaint* in this docket.
2. On January 23, 2018, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed its *Answer, Affirmative Defenses and Motion to Dismiss*.
3. On February 13, 2018, Staff filed its *Report*.
4. On February 28, 2018, Ameren Missouri filed its *Response to Staff Report*.
5. On March 19, 2018, Complainant filed both a *Notice Regarding Power Outage* and her *Response to Staff Report and Ameren's Response to Staff Report*.
6. In its March 21 Order, the Commission denied Ameren Missouri's motion to dismiss and ordered Staff to coordinate and file, no later than April 6, 2018, a proposed procedural schedule.

7. The parties have been unable to reach agreement on a hearing date and prehearing procedural requirements, so Staff recommends a prehearing conference to provide the parties a better avenue for discussion and agreement on procedural requirements, a procedural schedule, and a date for an evidentiary hearing.

8. Staff recommends the Commission adopt the following procedural schedule for this case:
