# ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

On October 31, 2017, Anthony Granillo filed a complaint against Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri"). On November 1, 2017, the Commission issued an *Order Giving Notice of Contested Case and Directing Answer*, included with the order was a letter explaining mediation as an alternative resolution to the formal complaint.

On December 19, 2017, the Commission ordered a prehearing conference, at the January 8, 2018, prehearing conference Mr. Granillo requested mediation.

The Commission will order Ameren Missouri to state whether they agree to mediation of the formal complaint.

### IT IS ORDERED THAT:

1. No later than January 18, 2018, Union Electric Company, d/b/a Ameren Missouri shall respond to Mr. Granillo's mediation request and state whether they are willing to enter into mediation.
