## **JOINT MOTION TO DISMISS**

COME NOW Kansas City Power & Light Company ("KCPL"), the Staff of the Missouri Public Service Commission ("Staff"), and Complainant Christian R. Atlakson, and also on behalf of the Office of the Public Counsel (hereinafter, collectively referred to as "the Parties") and respectfully state as follows to the Missouri Public Service Commission ("Commission"):

- 1. On August 1, 2005, the Parties filed with the Commission a Joint Motion for Continuance of the hearing scheduled for August 3, 2005. This action was taken because the Complainant had indicated to KCPL that he planned to make the necessary modifications to correct the dangerous condition created by the low electric service line and meter location, as further described in the Staff's June 29, 2005 report of its investigation.
- 2. On August 2, 2005, the Commission issued an Order granting the Parties' Joint Motion For Continuance and canceling the August 3, 2005 hearing.
- 3. On August 16, 2005, after receiving notification from KCPL that the necessary modifications have been completed, the Staff visited the Complainant's premises. The Staff confirms that the problems have been corrected and that electric service is now being provided to the

Complainant's home in compliance with the safety standards set forth in Commission rule 4 CSR 240-18.010.

4. Mr. Atlakson desires to dismiss his Complaint.

WHEREFORE, the Parties respectfully request that the Commission issue an Order dismissing the Complaint and closing this case.
