ORDER DIRECTING STAFF RECOMMENDATION

On September 20, 2018, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a request for variances. In its request, Ameren Missouri asked that the Commission grant it additional time, until March 31, 2019, to complete the annual inspection process described in 4 CSR 240-23.020. Ameren Missouri also requested a waiver for good cause of the 60-day notice requirement in 4 CSR 240-4.017(1)(D).

The Commission directed the Staff of the Missouri Public Service Commission (Staff) to file a recommendation or a status report stating when it expects to file a recommendation. On October 10, 2018, Staff filed a status report stating that it anticipated filing its recommendation by December 10, 2018. Ten days have passed and no objection to Staff's recommendation date has been filed. Therefore, the Commission will direct Staff to file its recommendation as proposed.

THE COMMISSION ORDERS THAT:

1. No later than December 10, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding the requested variances.

2. This order shall be effective when issued.
