On June 1, 2022, the Commission issued an order granting Union Electric Company d/b/a Ameren Missouri's (Ameren Missouri) request for a waiver of a portion of its tariff that sets out an Emergency Energy Conservation Procedure to be implemented when its coal supply reaches specified levels. The waiver was effective through July 23, 2022, and has been extended through September 9, 2022. The order granting the waiver directed Ameren Missouri to file tariff sheets to revise its tariff on a permanent basis. Ameren Missouri filed the revised tariff sheets on June 9, 2022, with a July 9, 2022 effective date. The effective date of the tariff sheets has also been extended to September 9, 2022.

On July 11, 2022, the Staff of the Commission (Staff) filed a recommendation to approve the tariff sheets, as substituted. The Office of the Public Counsel (OPC) filed a response to the tariff sheets on July 21, 2022. In that response, OPC raised concerns about the tariff language. On August 18, 2022, Ameren Missouri filed a reply to OPC's concerns stating that it has conferred with Staff and OPC and the parties had reached an

agreement as to the tariff language. Ameren Missouri filed substitute tariff sheets on August 18, 2022, reflecting the agreed to language.

The Commission directed any responses to the tariff sheets, as substituted, be filed no later than August 25, 2022. No responses were received.

The Commission has reviewed the changes to the Emergency Energy Conservation Plan, Staff's recommendation, and the responses and replies. The Commission will allow the tariff sheets to take effect on September 9, 2022, by operation of law.
