On August 31, 2022, the Commission issued its *Order Denying Motion for Expedited Treatment and Directing Filing* setting a deadline of September 12, 2022, for the parties to file a joint procedural schedule. On September 12, 2022, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a request for a one-week extension of time to file the procedural schedule. The company stated it has conferred with both the Staff of the Commission and the Office of the Public Counsel and neither objects to the extension. The Commission will grant the extension of time.

THE COMMISSION ORDERS THAT:

1. Evergy Missouri West's request for extension of time is granted.
2. The parties shall file a joint procedural schedule designed to resolve the issues of this matter no later than September 19, 2022.
3. This Order shall be effective when issued.
