## ORDER AMENDING PROCEDURAL SCHEDULE

Issue Date: December 12, 2013 Effective Date: December 12, 2013

On October 29<sup>1</sup>, The Empire District Electric Company ("Empire") filed the above-titled application. On December 6, the parties filed a Jointly Proposed Procedural Schedule ("proposed schedule").

On December 10, the Commission issued an Order Setting Procedural Schedule. The proposed schedule did not allow the Commission enough time to deliberate and write a Report and Order by the requested May 1, 2014 deadline. So, the Commission set the hearing about two weeks earlier than the parties had requested.

On December 12, the Staff of the Commission filed a Motion to Modify Procedural Schedule and Request for Variance. Staff asks the Commission to adopt the originally proposed schedule, and also asks for a variance from the Commission rule that requires the Commission to rule on the application within 120 days.<sup>2</sup>

Commission Rule 4 CSR 240-20.094(9) allows the Commission to grant a variance from Chapter 20 rules for good cause shown. Based upon the unanimity of the parties, the

Commission finds good cause to waive the 120-day requirement, and will set the proposed schedule as requested by Staff.

- 2. The procedural items agreed upon by the parties, and listed in paragraph 3 of the Jointly Proposed Procedural Schedule, are adopted, and the parties are ordered to comply with those items.
- 3. An evidentiary hearing shall be held on March 20-21, 2014, beginning at 8:30 a.m. each day, in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.
