**JOINT MOTION FOR EXTENSION OF TIME TO FILE JOINT LIST OF ISSUES,  
ORDER OF WITNESSES, ORDER OF CROSS-EXAMINATION,  
AND ORDER OF OPENING STATEMENTS, AND STATEMENT OF POSITIONS**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through Staff Counsel's Office, and Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") and request that the Commission extend the date for the filing of *Joint List Of Issues, Order Of Witnesses, Order Of Cross-Examination, And Order Of Opening Statements (List of Issues, etc.)* from Tuesday, July 29, 2014, to Thursday, July 31, 2014 and the date for the filing of the Statement Of Positions from Thursday, July 31, 2014, to Friday, August 1, 2014. In support thereof, the Staff, KCP&L, and GMO state as follows:

1. On July 25, 2014, the Commission issued an *Order Granting Joint Motion For Extension Of Time* in which it granted the Parties' *Joint Motion For Extension Of Time To File Joint List Of Issues, Order Of Witnesses, Order Of Cross-Examination, And Order Of Opening Statements* and set July 29, 2014 as the date for the filing of *List of Issues, etc.* On June 5, 2014, the Commission issued *Order Granting Motion To Amend Procedural Schedule* in which it set July 31, 2014, as the date for the filing of *Statements Of Position*.

2. The Staff, KCP&L, and GMO now file their motion to extend the date for the filing of a *List of Issues, etc.* and *Statement Of Positions*. The Staff, KCP&L, GMO,

and the Office of the Public Counsel ("Public Counsel") have been diligently working in these proceedings, and other Commission cases, and, among other things, are engaged in settlement discussions in these proceedings. The Staff, KCP&L, and GMO do not believe that moving the date for the filing of a *List of Issues, etc.* from July 29, 2014 to July 31, 2014, and the date for the filing of the *Statement Of Positions* from Thursday, July 31, 2014, to Friday, August 1, 2014 in these matters will unduly hinder the scheduled proceedings. The Evidentiary Hearing is set for Wednesday and Thursday, August 6-7, 2014. Public Counsel has expressed no opposition to these requests.

**WHEREFORE** the Staff, KCP&L, and GMO pray that the Commission extend the date for the filing of a *Joint List Of Issues, Order Of Witnesses, Order Of Cross-Examination, And Order Of Opening Statements* from Tuesday, July 29, 2014, to Thursday, July 31, 2014 and extend the date for the filing of *Statement Of Positions* from Thursday, July 31, 2014, to Friday, August 1, 2014.
