ORDER GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE

On December 16, 2013, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") filed the above-referenced application. The Commission issued notice of the application, and allowed an opportunity for intervention. The Commission received no intervention requests.

On February 6, 2014, the parties filed a Jointly Proposed Procedural Schedule. The Commission found the schedule reasonable, and adopted it.

On April 24, 2014, the parties filed a Joint Motion to Amend Procedural Schedule. The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Joint Motion to Amend Procedural Schedule is approved, as modified, and the parties shall comply with it and shall comply with this order.
