ORDER GRANTING INTERVENTION

The Missouri Public Service Commission is granting Earth Island Institute d/b/a Renew Missouri's ("Renew Missouri") *Application to Intervene*, with a limitation.

The Commission opened this file for the annual report and annual plan² ("RES report and plan") of The Empire District Electric Company regarding renewable energy standards ("RES").³ Upon the opening of such file, the Commission's regulations require notice,⁴ a Staff report,⁵ and the opportunity for comment from "any interested persons or entities [.]"⁶ Under that language, intervention is unnecessary for such person to file comments on the report and plan. But the report and plan are highly confidential in part, and highly confidential material is available only through a "party."⁷

A "party" includes an intervenor, and intervenors are expressly contemplated in an investigation.⁸

Renew Missouri is uniquely suited to comment on the RES report and plan. Granting Renew Missouri access to highly confidential information is likely to improve the quality of Renew Missouri's comments. Therefore, granting the proposed intervention would serve the public interest.⁹

But an investigation is all that this file includes. Though the Commission may issue a procedural schedule, no law requires any final order or any other further procedure on the filing of a RES report and plan. Therefore, the Commission will grant intervention limited ¹⁰ to accessing the highly confidential versions of the RES report and plan.

THE COMMISSION ORDERS THAT:

- 1. The Earth Island Institute d/b/a Renew Missouri's *Application to Intervene* is granted as described in the body of this order.
 - 2. This order shall become effective upon issuance.
