On July 14, 2014, Boone Electric Cooperative and the City of Columbia, Missouri, filed a joint application with the Missouri Public Service Commission requesting authorization to transfer electric service for a building or other structure you own or for which you are the responsible electric customer to the City of Columbia from the Boone Electric Cooperative.
