JOINT RESPONSE TO ORDER REGARDING CUSTOMER NOTICE

COME NOW Staff of the Missouri Public Service Commission, by and through the undersigned counsel, on behalf of the Staff, City of Columbia, Missouri and Boone Electric Cooperative and submits this *Joint Response to Order Regarding Customer Notice* to the Missouri Public Service Commission. In support thereof, the parties respectfully state the following:

- 1. On July 14, 2014¹, the City of Columbia, Missouri and Boone Electric Cooperative filed a *Joint Application* with the Commission requesting an order approving their agreement to change electric service to certain structures in the city from the cooperative to the city.
- 2. On August 5, in its *Order Regarding Customer Notice* the Commission ordered the cooperative and the city to:
 - a) Provide Staff with the names and addresses of all current cooperative members and owners of record for any structure that is affected by the Joint Application by August 14th.
 - b) File a draft notice by August 21st that, among other things, contained information on how those affected by the Joint Application may participate and be heard in the action.

This filing complies with both requirements of Commission's August 5th Order.

- 3. A list of the current cooperative members and accompanying property owners for the structures affected by the Joint Application was provided to Staff via email, on July 24, a copy of which is attached hereto as Attachment 1.
- 4. Attached hereto as Attachment 2 is a draft notice that Staff, the cooperative and the city suggest be provided to the all current members and property owners of record.
- 5. Acting Public Counsel has reviewed the draft notice and has stated that he does not object to it. The parties recommend that the deadline to intervene for those members or property owners subject to the Joint Application be thirty days (30) from the date of the notice.

WHEREFORE, Staff, on behalf of Staff, City of Columbia and Boone Electric Cooperative files this *Joint Response to Order Regarding Customer Notice* to comply with the Commission's August 5th Order.
