**SECOND MOTION TO ACCEPT CORRECTIONS TO STAFF WITNESS JOHN
ROGERS’ PREFILED DIRECT, REBUTTAL AND SURREBUTTAL TESTIMONY**

COMES NOW Staff of the Missouri Public Service Commission, by and through undersigned counsel, and hereby files its *Second Motion to Accept Corrections to Staff Witness Rogers’ Prefiled Direct, Rebuttal And Surrebuttal Testimony* (“*Motion*”), stating:

1. It has come to Staff’s attention that there are minor errors in the prefiled direct, rebuttal and surrebuttal testimony of Staff witness John Rogers.

2. Accordingly, Staff seeks leave of the Commission to make the following corrections:
