JOINT APPLICATION

COME NOW The Empire District Electric Company (Empire) and Carthage Water & Electric Plant (CW&EP), a municipal utility of the City of Carthage, Missouri (Carthage), hereinafter referred to collectively as "Applicants," and for their Joint Application, pursuant to Section 394.315, RSMo (2000), 4 CSR 240-2.060 and 4 CSR 240-3.140, respectfully state as follows:

APPLICANTS

1. Empire is a Kansas corporation with its principal office and place of business at 602 Joplin Street, Joplin, Missouri 64801. Empire is engaged in the business of providing electrical and water utility services in Missouri to customers in its service areas. Empire is an "electrical corporation," a "water corporation," and a "public utility" as those terms are defined in § 386.020 RSMo. 2000, and is subject to the jurisdiction and supervision of the Commission as provided by law. Empire has no pending or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or its rates, which have occurred within the three years immediately preceding the filing of this Joint Application. Empire has no overdue Commission annual reports or assessment fees. Empire's documents of incorporation have been previously filed with the Commission in Case No. EF-94-39, and said documents are incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G). A Certificate of Authority from the Missouri Secretary of State to the effect that Empire, a foreign corporation, is duly authorized to do business in the State of Missouri was filed with the

Commission in Case No. EM-2000-369, and is incorporated herein by reference.

- 2. Carthage Water & Electric Plant is a municipal utility owned by the City of Carthage which is a charter city organized and existing under the laws of Missouri with the principal office of Carthage Water & Electric Plant located at 149 East Third Street, Carthage, Missouri 64836. It is engaged in the distribution of electric energy and service to its citizens. Carthage Water & Electric Plant has no pending or final judgments or decisions against it from any state or federal agency or court that involve its customer service or rates within the three years immediately preceding the filing of this Joint Application.

FACTS

- 4. Empire currently provides electrical service to three advertising signs along the east side of Highway 71, just south of the Highway HH intersection, in Carthage, Missouri. Two of these signs are owned and operated by Lamar Advertising, 751 S. Malang Road, Joplin, MO 64804. The third sign is owned and operated by Grace Energy Corporation d/b/a Fastrip #38, P.O. Box 514, Carthage, MO 64836.
- 5. Empire has an overhead, 12 Kv feeder line that runs along Highway 71, and in front of the McCune-Brooks Regional Hospital, 3125 Dr. Russell Smith Way, Carthage, Missouri 64836. The Hospital has asked Empire to relocate this line to the backside of the Hospital.
- 6. After this relocation, a new highway crossing would be required for Empire to continue serving the three advertising signs referenced above. This would add additional expense to the relocation project. A less expensive alternative is to change the signs' supplier from Empire to Carthage Water and Electric Plant (CW&EP). If the supplier is changed, the cost of this relocation will be paid for by CW&EP.
- 7. In order to complete this transaction, Empire will sell to CW&EP, at net book value (approximately \$3,933.24), three poles, 1,108 feet of 7200 volt conductor, crossarms, anchors and guys. Empire will also perform the necessary relocation. With these facilities, CW&EP will be able to serve the customers from an existing circuit.
- 8. A diagram of the properties, Carthage's existing line and Empire's existing lines is attached hereto and marked **Appendix A**.
- 9. The customers identified above have consented to the proposed change of supplier from Empire to CW&EP. Their verified, written consents are attached hereto as **Appendix B** and **Appendix C**, respectively.

STATUTE

10. Section 394.315.2, RSMo provides in relevant part that [t]he public service commission, upon application made by an affected party, may order a change of suppliers on the basis that it is in the public interest for a reason other than rate differential, and the commission is hereby given jurisdiction over municipal utilities to accomplish the purpose of this section.

PUBLIC INTEREST

11. The proposed change of supplier is in the public interest because it will allow the continued provision of electric service to the identified customers without the need to make additional investment in relocating electric lines. Thus, the proposed change of supplier is in the public interest for a reason other than a rate differential.

WHEREFORE, Joint Applicants respectfully request that the Commission issue its order:

- (a) Finding that the change of electric supplier proposed herein is in the public interest and approving the proposed change of electric supplier; and
- (b) Granting such other relief as is deemed necessary to accomplish the purposes of this Joint Application.


