On May 28, 2013, KCP&L Greater Missouri Operations Company (“GMO”) filed its 2013 Annual Renewable Energy Standard Compliance Plan and Report pursuant to Commission Rule 4 CSR 240-20.100. On the same date, it also filed a Revised 2012 Plan and Report (“Plans and Reports”).

GMO filed these Plans and Reports in File No. EE-2013-0453. That file was opened to rule upon GMO’s Application for Variance from a Commission rule requiring GMO to file its Plan and Report by April 15. The Commission will close File No. EE-2013-0453 as it has already granted KCP&L the variance. The Commission opens File No. EO-2013-0505 to receive the Plans and Reports.

The Commission will direct notice and establish a deadline for Staff to file a report and for other interested entities to file comments.

THE COMMISSION ORDERS THAT:

1. File No. EE-2013-0453 is closed.
2. The Commission’s Data Center shall provide notice of this order upon each party to File Number EO-2012-0349 and ER-2012-0175.

3. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within KCP&L Greater Missouri Operations Company's service area.

4. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing KCP&L Greater Missouri Operations Company's service area and to the news media serving KCP&L Greater Missouri Operations Company's service area.

5. The Staff of the Missouri Public Service Commission shall examine KCP&L Greater Missouri Operations Company's Annual Renewable Energy Standard Compliance Plan and file a report of its review no later than July 12, 2013.

6. No later than July 12, 2013, the Office of the Public Counsel, and any other interested person or entity, may file comments regarding KCP&L Greater Missouri Operations Company's Annual Renewable Energy Standard Compliance Plan.

7. This order shall become effective upon issuance.
