Background

- 1. On June 10, 2011, Thomas L. Chaney (Applicant) filed an *Application For Change Of Electric Service Provider* (*Application*) requesting the Commission to approve changing his electric supplier from Cuivre River Electric Cooperative, Inc. (Cuivre River) to Union Electric Company d/b/a Ameren Missouri (Ameren Missouri).
- 2. On March 13, 2012, the parties participated in a prehearing conference and discussed the filing of motions for summary determination and responses. On the same date the Commission's *Notice of Case Procedure* ordered the discussed procedure, in particular, the Staff's response deadline of 15 days after Ameren Missouri and Cuivre River filed a motion for summary determination. On April 19, 2012, Ameren Missouri and Cuivre River filed a *Joint Motion to Dismiss for Lack of Subject Matter Jurisdiction and for a Determination on the Pleadings* and a *Memorandum of Law in Support of the Motion to Dismiss for Lack of Subject Matter Jurisdiction and for a Determination on the Pleadings*.

- 3. Due to the Staff's workload and the undersigned's recent return from an extended leave, the Staff requests an extension until May 21, 2012, to respond to the filings.
- 4. The Applicant, Ameren Missouri, Cuivre River, and the Office of the Public Counsel do not object to this request.
