- 1. On May 11, 2012, the Staff filed its Sixth Status Report in which it stated that on Wednesday, May 9, 2012, the Staff and Union Electric Company d/b/a/ Ameren Missouri ("Ameren Missouri") met by conference call to discuss the Staff's draft recommendation (sent to Ameren Missouri for its review) and Ameren Missouri's pending Application.
