**NOTICE OF DPI TELECONNECT, LLC TO REGARDING ITS
DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER**

Comes now dPi Teleconnect, LLC (“dPi” or the “Company”) and submits this Notice Regarding its Designation as an Eligible Telecommunications Carrier (“ETC”) in Missouri for prepaid wireless service in the exchanges served by AT&T Missouri.

1. dPi was granted a Certificate to Provide Basic Local and Exchange Access Telecommunications Service in the State of Missouri in Case No. TA-2000-44 by Order effective November 29, 1999. dPi was granted ETC status as a wireline carrier by the Commission for the receipt of FUSF support in certain specified AT&T exchanges in Case No. CO-2010-0054 by Order effective June 9, 2010.

2. On October 8, 2010, dPi filed its Application to Amend its Designation as an Eligible Telecommunications Carrier, in which it sought amendment of its ETC designation to include dPi’s wireless service as eligible for low-income FUSF support in the exchanges for which dPi has already received ETC designation. The Commission granted dPi’s amendment to its ETC status for the purpose of providing wireless service in the exchanges served by AT&T Missouri for which dPi has already been granted ETC status on January 19, 2011.

3. dPi hereby notifies the Commission that its affiliate, TAG Mobile, LLC, is concurrently filing an application for designation as a wireless ETC for those exchanges currently served by dPi. Upon the Commission’s designation of TAG Mobile, LLC as a wireless ETC in the State of Missouri, dPi will relinquish its wireless ETC status in Missouri. dPi will

continue to operate as an ETC in Missouri for its wireline services.
