1      Q.      Please state your name for the record please.

2      A.      Dave Stogsdill

3      Q.      By whom are you employed and in what capacity?

4      A.      I am employed by the Rolla Municipal Utilities as the Operations Manager.

5      Q.      Please briefly describe the duties of that position and your professional background.

6      A.      I am responsible for the overall plant operations of the electric and water system. I have  
7              been the Operations Manager since 1992. Prior to that time I was the Operations  
8              Foreman. I have approximately 21 years of experience in the electric and water utility  
9              plant operations.

10     Q.      Please briefly describe you educational background.

11     A.      I am a high school graduate and have attended numerous educational programs and  
12              seminars related to the operation of municipal electric and water systems.

13     Q.      What is the purpose of your testimony here today?

14     A.      The purpose of my testimony is to affirm that the information shown in the feasibility  
15              study, as presented by Mr. Bourne, is a reasonable and do-able approach from an  
16              operational standpoint.

17     Q.      Did you participate in the production of the feasibility study attached to Mr. Bourne's  
18              direct testimony?

19     A.      Yes. Mr. Bourne and I conferred on the issues presented in that study. I supplied Mr.  
20              Bourne with the appropriate estimates of labor and materials for the various projects

3        A.    Yes, I am familiar with it.

4        Q.    Do you have experience in the type of construction described in the feasibility study?

7            the proposals shown in the feasibility study, reasonable?

8        A.    Yes. Based on my experience managing the electric utility plant operations, in order to  
9            build a safe and reliable system and with the least amount of inconvenience to the  
10          customers, they are.


11      Q.    Does this conclude your direct testimony?

12      A.    Yes, at this time.


