Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, the Office of the Public Counsel, and the Missouri Industrial Energy Consumers (MIEC) filed a motion on May 18, 2022, asking the Commission to make additional modifications to the Report and Order issued on April 19, 2012, regarding Ameren Missouri's continued participation in the Midcontinent Independent System Operator, Inc. (MISO). The movants ask the Commission to modify the Report and Order to extend Ameren Missouri's permission and authority to transfer functional control of its transmission to MISO indefinitely, rather than for an additional term of years. The motion proposes that the Commission retain authority to require further proceedings respecting Ameren Missouri's MISO participation if that becomes necessary.
