Kansas City Power & Light Company (KCP&L), KCP&L Greater Missouri Operations Company (GMO), the Commission’s Staff, the Office of the Public Counsel, and Dogwood Energy, LLC filed a motion on June 16, 2017, asking the Commission to modify some of the terms of the stipulation and agreement regarding KCP&L and GMO’s participation in the Southwest Power Pool, which the Commission approved in a June 19, 2013 order. Before ruling on the motion the Commission will give the other parties an opportunity to respond.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to the Joint Motion of Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, Staff of the Missouri Public Service Commission, Office of the Public Counsel, and Dogwood Energy, LLC to Modify Stipulations shall do so no later than June 22, 2017.

2. This order shall be effective when issued.
