ORDER GRANTING MOTION TO MODIFY STIPULATION REQUIREMENTS

Issue Date: June 28, 2017

Effective Date: July 8, 2017

On June 16, 2017, Kansas City Power & Light Company (KCP&L), KCP&L Greater Missouri Operations Company (GMO), the Staff of the Commission, the Office of the Public Counsel, and Dogwood Energy (Movants) jointly filed a motion to modify the Commission-approved requirements in the May 16, 2013 stipulation and agreement in this matter.¹ Specifically, the Movants ask the Commission to modify the previously approved stipulation so that KCP&L and GMO are no longer required to file a pleading on June 30, 2017 regarding their continued participation in a regional transmission organization or its operation under an independent coordinator of transmission. Further, the Movants ask the Commission to extend the “interim and conditional” approval described in the May 16, 2013 stipulation and agreement by three years, from 2018 to 2021, with a resulting three-year extension of the timeline for review of that approval as established in the May 16, 2013 stipulation and agreement.

¹ The Movants also filed their motion in File No. EO-2012-0136, which relates to GMO. File No. EO-2012-0136 was consolidated into this file so it is not necessary to make a separate filing, or issue a separate order, in File No. EO-2012-0136.

The Commission ordered that any party wishing to respond to the motion to modify do so by June 22, 2017. No response has been filed. The Commission will consider the motion to be unopposed.

After considering the proposed modification to the May 16, 2013 stipulation and agreement, the Commission finds that those modifications are reasonable. The Commission will grant the unopposed motion.

THE COMMISSION ORDERS THAT:

1. The Joint Motion of Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, Staff of the Missouri Public Service Commission, Office of the Public Counsel, and Dogwood Energy is granted.
2. This order shall become effective on July 8, 2017.
3. This case may be closed on July 9, 2017.
