REGARDING REVISED TARIFFS**

On October 31, 2017, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company filed revised tariff sheets with an effective date of November 30, 2017, to reflect revisions to the approval of the Long-Lead Projects and Special Provision for Income-Eligible Multi-Family Program that was included in the Stipulation and Agreement in File Nos. EO-2015-0240 and EO-2015-0241 approved by the Commission on October 19, 2017. The Commission will direct its Staff to review the revised tariff sheets and submit a recommendation. The Commission will also provide an opportunity for other parties to comment on the tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than November 14, 2017, Staff shall review the revised tariff sheets submitted by Kansas City Power & Light Company and KCP&L Greater Missouri

Operations Company and file a recommendation as to whether the tariff sheets should be approved.

2. Any party wishing to respond or comment on the revised tariff sheets submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file its response no later than November 14, 2017.

3. This order shall be effective when issued.
